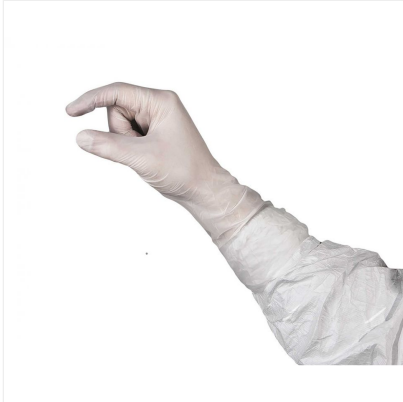

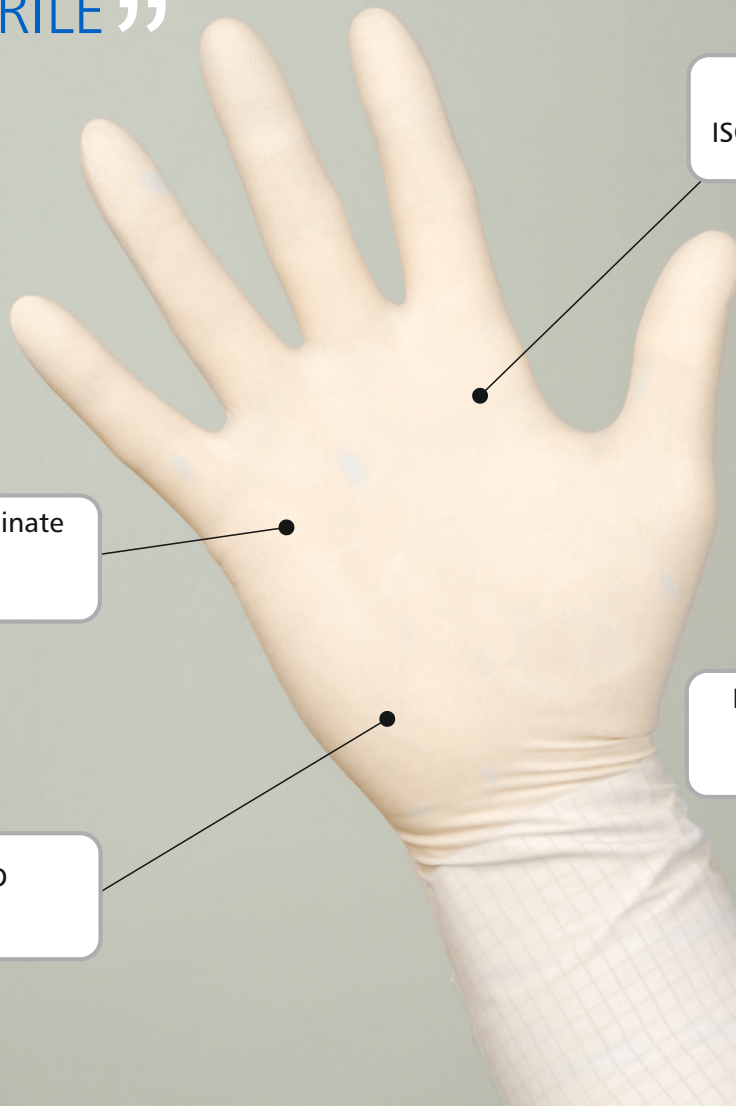

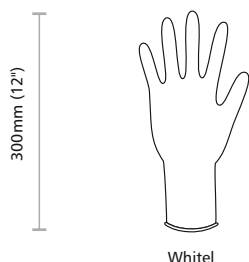

LOT NUMBER:	This is shown on the sealed outer bag and the carton to provide product traceability.
PACKAGING:	100 pieces per sealed inner PE bag; One sealed inner PE bag per sealed outer PE bag; 10 outer PE bags per carton liner; One carton liner per carton (1000 pieces).
